PRIVACY

ORTEA SpA respects the privacy of its website users. This page describes the management of this website with regards to processing the personal data of users visiting it. This information is provided also in pursuance of Section 13 of Legislative Decree no. 196/2003 (Code of conduct regarding personal data processing for any entity interacting with web-based services).

1. Navigation

Navigation data

The information systems and software procedures relied upon to operate this website acquire personal data as part of their standard functioning; the transmission of such data is an inherent feature of Internet communication protocols.

Data Controller

Cookies
